**Stewardship Committee**: Chair David Mahood, Rosellyn McIver, Todd Gray (ex-officio), (Bob Wilson until mid 2023).

The Stewardship Committee met regularly during the fall to prepare for the 2024 giving campaign. The Stewardship Committee's goal was to receive pledge cards from 90% of past giving units. The pledge card was redesigned and distributed to the congregation.

A newly added Commitment Card, for regular visitors and non-members, was introduced and made available to interested attendees. The Stewardship Committee followed up with members that had not pledged, but typically do so.

93.5% of pledges for 2023 were received due to relocations and a few pledges not being fulfilled.

We held four blood drives in 2023, which helped many people. Each successful donation saves up to 3 lives, so we are very thankful for Susan Vander worth's leadership efforts to contact potential donors. There were **58** donations. She was ably assisted by Barb Owens and Sue Ruotsala.

Additionally, our wonderful Galilee Garden, under the guidance of Phoebe Lake, produced **895 pounds** of healthy organic vegetable for our neighbors at Bread Partners in Washington County.

The Souper Bowl of Caring lunch held in February 2023 garnered \$922 which was given to Bread Partners.

During the Christmas season, you provided holiday gifts for 25 citizens at the Brenham State Living Center and **21** coats for children being served by Presbyterian Children's Homes. This effort was led by the very capable Susan Gray.

We also coordinated the four church –wide special offerings for the Presbyterian Church. They are the One Great Hour of sharing, the Pentecost Offering, the Peace and Global Witness Offering, and the Christmas Joy Offering. We contributed to each special offering.

It recalls the Bible Verse "The Lord loves a cheerful giver" So thank you for your generous giving and to our committee members: Phoebe Lake, Rob Lake, Linda Newton, Charles Nitsch, Barb Owens, Milton Ressmann and Susan Vanderworth.

Finance Committee: Chair Paul Ehlert, Elder Robert Lake, Bob Charlton, Fort Flowers, Todd Gray (ex-officio)

Main efforts for this year have been to monitor income, keep bills paid and explain the financial health of BPC especially for a new pastor. For 2024 committee focused on how best to use new cost reduction from Brenham Children's Chorus and develop an interest income. An Interest-bearing account with Texas Presbyterian Foundation Money Market is established. The "Pastor Annual Support Account" of \$20,000/in 2023 and the establishment of a "Reserve for Replacement Fund" of \$16,000/in 2024 have been approved by the Session.

Designated Reserve funds for unforeseen issues of long-term maintenance and replacement have increased by a Historic Repairs account at end of 2023 of \$40,000.

Sanctuary & Education Building Repair and Renovations Commission: Todd Gray, Tommy Upchurch, Elder Tom Newman, Jeff Damon, Jerrel Branson (Elder Bob Wilson until mid 2023).

Cost plus contract with Scott Eason Contracting was completed per the initial Phase Scope of Sanctuary Repair/paint and beginning of Education Wing Renovations/Hardie Plank. Donated funds received in 2022 plus the \$20,000 contingency loan from Presbytery were sufficient to cover estimated costs. Before work was completed in 2023 additional donations covered all cost plus \$5000 without the use of the \$20,000 contingency loan. Funding for completion of Hardie siding on the south and west elevations has \$10,000 funds with a second grant from Presbytery to finish the Hardie siding. Additional funds may become available the end of the first quarter to start this last phase of lower floor Hardie Siding.

### Presentation of 2024 Budget to the Congregation: Interim Treasurer Todd Gray

Budget for 2024 is a balanced budget supporting a full-time pastor with compensation of 10 years of experience including a supporting secretary for two days a week. The 2023 budget was for a half time pastor and secretary. Without these positions filled 2023 reserve funds were developed. These 2023 reserves created a "Pastor Annual Support Account" and are available for new pastor expenses that might exceed the present PNC reserve fund, such as candidate & family interview travel, moving expenses, and additional compensation if required. Budgeted Income \$246,000 equal budget expenses \$246,000. Budgeted expenses have been increased to minimum 2023 spending levels or invoices for 2024 rates. Additional reserves are possible in 2024 as the funded new pastor & secretary will not be in place for at least the first quarter. Our regular pulpit supply costs are significantly below pastor/secretary cost. Improved 2024 compensation for building use from BCC for the full year, increased pledges, developing an interest income stream allow the step change to full time pastor.

**Action:** Hard copies of 2023 Annual report with 2024 Budget were distributed to the congregation.

# Report from Pastor Nominating Committee: Jerry Newman, Chair

Our Pastor Nominating Committee was convened in May last year, and was ably assisted by Rev. Matt Morse, as our designated Presbytery liaison. We put together our church's

Ministry Discernment Profile, which was accepted by Session and posted online in September.

Since then, we have sifted through 11 potential matches generated by the Church Leadership Connection, a kind of clearing house for matching churches with applicants. Matches continue to come in. At the same time, Beth Flowers, through her connection with Austin Presbytery Seminary has provided us with 14 other names who might have an interest. We have followed up with each of them, and continue to do so.

With so many churches seeking so few candidates, we recognize this will not be a quick process. We ask for your patience and prayerful support as we continue to search for the pastor that God has already chosen for our Church.
